RESOLUTION NO. 91-20

ADOPTING AND CONFIRMING THE RESOLUTION OF THE BOARD OF OFFICERS PERTAINING TO THE ABSORPTION OF NON-OFFICERS IN THE PNP AND PRESCRIBING THE CORRESPONDING RANK INSIGNIAS THERETO, AND THE RESOLUTION OF THE SAME BOARD GRANTING TESTIMONIAL ELIGIBILITY TO THOSE WHO DO NOT POSSESS POLICE ELIGIBILITY UPON ABSORPTION TO THE PNP

WHEREAS, Section 85 of Republic Act No. 6975, otherwise known as the Department of the Interior and Local Government Act of 1990, has authorized the creation of a Board of Officers composed of a Napolcom Commissioner as Chairman and one representative each from Philippine Constabulary, Integrated National Police, Civil Service Commission, and the Department of Budget and Management, for the purpose of studying and prescribing the criteria for the adjustment of ranks and establishment of one linear roster of officers and non-officers of the PNP and the rationalization of compensation and retirement system of members thereof;

WHEREAS, under Department Order No. 91-17 issued by the Secretary of the Department of the Interior and Local Government, the aforesaid Board of Officers was constituted on 16 January 1991 with the following membership:



Adopted this 28th day of November, 1991, at Makati, Metro Manila.


