MEMORANDUM CIRCULAR NO. 2000-004

**AMENDING NAPOLCOM MEMORANDUM CIRCULAR NO. 99-07
DATED AUGUST 27, 1999 ON THE SUBJECT "PRESCRIBING THE
GUIDELINES FOR THE GRANT OF CULTURAL MINORITY
PREFERENCE"**

WHEREAS, Memorandum Circular No. 99-07 was adopted and approved by the Commission on August 27, 1999 prescribing the guidelines for the grant of Cultural Minority Preference to members of cultural minorities who failed in the police examinations administered by the Commission;

WHEREAS, such grant of preferential consideration to members of the indigenous sectors of society failed to indicate in the dispositive portion of said Circular, the nature of grant to be extended, thus the need for an amendatory issuance;


NOW, THEREFORE, this Commission hereby amends the dispositive portion of Napolcom Memorandum Circular No. 99 - 07 to read as follows:


*"NOW THEREFORE, the Commission in the exercise of its statutory power to administer and control the PNP under Section 6 of Article XVI of the Constitution, in relation to Section 14 of Republic Act No. 6975 as amended by Section 5 of R.A. No. 8551 has resolved to **GRANT** as it hereby **GRANTS** cultural minority preference to members of the indigenous sectors of society by giving additional five (5) points to those who failed in Napolcom administered police examinations under the following conditions;*


1. That a certification from the National Commission on Indigenous Peoples, Main Office, Quezon City, for non-Muslim tribes and from the Office of Muslim Affairs for Muslim tribes, be submitted together with a copy of the Information Sheet filed with any of these offices, showing therein the examinee's membership in a cultural community;
2. That the preference shall be availed of only once by an examinee;
3. That membership in a cultural community either by affinity or conversion shall not be considered;
4. That this privilege shall be availed of only for the next three (3) years effective upon approval."

This Memorandum Circular shall take effect immediately.



**PRESCRIBING THE GUIDELINES FOR THE GRANT OF
CULTURAL MINORITY PREFERENCE**

WHEREAS, Section 9 of R. A. No. 6040, reiterated by Section 23 of PD 807 and Section 25, Subtitle A, Title I, Book V of EO No. 292, highlighted the policy of the government to facilitate the integration of the members of the cultural communities and accelerate the development of areas occupied by them;

WHEREAS, in consonance with this policy, the Commission has declared that members of cultural minorities who failed in police examinations administered by the Commission, shall be given additional five (5) points as member and for those who are in the police service, they shall enjoy an additional one (1) point for every year of service, but not to exceed five (5) points.


NOW, THEREFORE, the Commission in the exercise of its statutory power to administer and control the PNP under Section 6 of Article XVI of the Constitution, in relation to Section 14 of Republic Act No. 6975 as amended by Section 5 of R.A. No. 8551 HAS RESOLVED, AS IT HEREBY RESOLVES, to grant cultural minority preference to members of cultural communities who failed in Napoleom administered police examinations under the following conditions:



1. 4. That this privilege shall be availed of only for the next five (5) years effective upon approval.


