MEMORANDUM CIRCULAR NO. 2007-002

ESTABLISHING PNP SPECIAL ORDERS AS BASIS FOR EXPERIENCE IN ALL PNP 2ND LEVEL PROMOTIONS THAT WERE APPROVED PRIOR TO CY 2005

WHEREAS, prior to 2004, all regular promotions recommended by the PNP Promotion Boards were submitted to the NAPOLCOM for approval;

WHEREAS, in line with the addition and membership of NAPOLCOM Representatives in the different PNP Promotion Boards per NAPOLCOM Resolution No. 2004-137, as amended, 2nd level promotions were no longer forwarded to the Commission for approval;

WHEREAS, the late attestation of promotion/appointment orders that the PNP issued based on the confirmations made by the NAPOLCOM and the PNP Promotion Boards that had NAPOLCOM Representatives resulted in confusion as to when time-in-grade (TIG) or experience actually commences;


WHEREAS, the CSC, upon the request of the NAPOLCOM, issued Resolution No. 050002 dated 10 January 2005 providing that the experience of a police officer in a certain rank shall commence on the effectivity date of his or her PNP special order;

WHEREAS, despite this CSC policy, the Commission had been receiving reports of promotions that were denied by the some Promotion Boards that computed experience based on the date of attestation;

WHEREAS, to uphold the promotions of police officers that meet the qualification standards for promotion, including the required experience as computed from the effectivity date of their special orders, there is a need to issue a NAPOLCOM memorandum circular implementing this policy;

NOW, THEREFORE, the Commission, pursuant to its constitutional mandate to administer and control the PNP, HAS RESOLVED TO ESTABLISH, AS IT HEREBY ESTABLISHES, PNP Special Orders as basis for experience in all PNP 2nd level promotions that were approved by the NAPOLCOM and PNP Promotion Boards that included NAPOLCOM Representatives prior to CY 2005.
