**MEMORANDUM CIRCULAR NO. 2007 - 004**

**AMENDING NAPOLCOM MEMORANDUM CIRCULAR NO. 2005-008 BY REDUCING THE NUMBER OF COMMITTEES THAT WILL ASSIST THE SENIOR OFFICERS PLACEMENT AND PROMOTION BOARD (SOPPB) IN DRAWING UP THE LIST OF ELIGIBLES INTO TWO (2) COMMITTEES**

**WHEREAS**, the Commission issued Memorandum Circular No. 2005-008 on December 19, 2005 entitled "*Amending Further Section 7 (b) of Napolcom Memorandum Circular No. 95-04 dated January 12, 1995 Entitled "Guidelines and Procedures Governing the Selection and Placement of Police Commissioned Officers to Key Positions in the PNP"*

**WHEREAS**, under said Napolcom Memorandum Circular, the SOPPB shall be assisted by three (3) Committees which shall draw up the list of eligibles for the different key positions, namely;

**Committee A** for the positions of Regional Directors, Directors of NSUs, District Directors of NCRPO and Deputy Directors of the Directorial Staff

**Committee B** for the positions of Deputy Director of NSUs and PROs, Chiefs of Directorial Staff of NSUs and PROs, and Executive Officers of the Directorial Staff

**Committee C** for the positions of Directors of Provincial and City Police Offices

**WHEREAS**, the SOPPB thru the Chief, PNP submitted for consideration of the Commission SOPPB Resolution No. 2007-007 which reduced the number of Committees from three (3) to two (2) and provided the new composition thereof, as follows:

**Committee A** for the positions of Regional Directors, Directors of NSUs, Deputy Directors of Directorial Staff and Deputy Directors for Administration of PROs

**Committee B** for the positions of Deputy Directors for Administration and Operations of NSUs, Executive Officers of Directorial Staff, Deputy Directors for Operations of PROs, Chief Directorial Staff of NSUs/PROs, and Director of Provincial/City Police Office

**WHEREAS**, after review of the SOPPB Resolution, the Commission finds the same to be in order;

**NOW, THEREFORE**, the Commission, pursuant to its Constitutional mandate to administer and control the PNP, **HAS RESOLVED TO AMEND, AS IT HEREBY AMENDS**, Napolcom Memorandum Circular No. 2005-008 by reducing the number of committees that will assist the Senior Officers Placement And Promotion Board (SOPPB) in drawing up the list of eligibles into two (2) committees to be constituted as follows:

**Committee A** shall draw up eligibles for the positions of Regional Directors, Directors of NSUs, District Directors of NCRPO, deputy Directors of Directorial Staff And Deputy Directors for Administration of PROs:


- Chairman - TDCO
- Vice-Chairman - TDPRM
- Members - TCDS
- Deputy DPL
- Deputy DIDM
- Deputy DL
- Deputy DC
- Deputy DI
- Director, LS

**Committee B** shall draw up eligibles for the positions of Deputy Directors for Administration and Operations of NSUs, Executive Officers of Directorial Staff, Deputy Directors for Operations of PROs, Chief Directorial Staff of NSUs/PROs, and Director of Provincial/City Police Office:

- Chairman - TCDS
- Vice-Chairman - TDIDM
- Members - Deputy DO
- Deputy DPCR
- Deputy DHRDD
- Deputy DPRM
- Deputy DRD
- Deputy Director, LS
