MEMORANDUM CIRCULAR NO. - 2008-019

**UPGRADING OF THE PUERTO PRINCESA CITY POLICE STATION INTO A TYPE "C"
CITY POLICE OFFICE AND PLACING IT UNDER THE DIRECT ADMINISTRATIVE AND
OPERATIONAL CONTROL OF THE REGIONAL DIRECTOR,
POLICE REGIONAL OFFICE 4-B (MIMAROPA)**

WHEREAS, Title III, Chapter I of Republic Act (R.A.) No. 7160, otherwise known as the "Local Government Code of 1991" provides for the role and creation of cities either component or highly urbanized;

WHEREAS, Presidential Proclamation No. 1264 dated March 26, 2007 provides for the conversion of the City of Puerto Princesa in the province of Palawan from a component city into a highly urbanized city;

WHEREAS, NAPOLCOM Resolution No. 2005-140 provides for the new parameters for the classification of the PPOs, CPOs and Component City/Municipal Police Stations;


WHEREAS, Napolcom Memorandum Circular No. 2004-002 provides that City Police Stations of highly urbanized cities outside of NCR and independent component cities shall be under the direct command and control of the PNP Regional Director and equivalent to a provincial office;

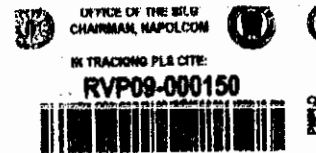
WHEREAS, the PNP submitted to this Commission, for consideration, General Orders Number DPL 08-18 upgrading the Puerto Princesa City Police Station to a Type "C" City Police Office and placing it under the direct administrative and operational control of the Regional Director, PRO 4-B (MIMAROPA);


WHEREAS, after review of the PNP's recommendation, the Commission finds the upgrading to be in accordance with R.A. No. 7160 and NAPOLCOM Resolution No. 2005-140:

NOW THEREFORE, this Commission, pursuant to its constitutional mandate to administer and control the PNP, **HAS RESOLVED TO UPGRADE, AS IT HEREBY UPGRADES**, the classification of the Puerto Princesa City Police Station into a Type "C" City Police Office and placing it under the direct administrative and operational control of the Regional Director, PRO 4-B (MIMAROPA).
