RESOLUTION NO. 2005-004

**APPROVING THE ORIGINAL APPOINTMENTS OF MS. CRISTINA D. YABUT
AND FIVE (5) OTHER NUPS TO REGULAR PLANTILLA POSITIONS
IN THE PNP**

WHEREAS, the Commission, under Section 14 (a-1) of Republic Act No. 6975, as amended by Section 5 of RA 8551, exercises the following function, to wit:

1. Develop policies and promulgate a police manual prescribing rules and regulations for efficient organization, administration, and operation, including criteria for manpower allocation, distribution and deployment, recruitment, selection, promotion, and retirement of personnel and the conduct of qualifying entrance and promotional examinations for uniformed members;

WHEREAS, under Item 3, Section 94 of the Implementing Rules and Regulations of Republic Act No. 6975, it is stated, inter alia:

3. Philippine National Police. Appointments of PNP uniformed personnel shall be in accordance with Section 36 hereof. Appointments to all regular positions of PNP non-uniformed personnel shall be approved by the Commission. However, signing of the appointments shall be made as follows:

3.1 Section Chief or higher - Chairman

3.2 Lower than Section Chief:

3.2.1 Central Office - Chief, PNP

3.2.2 Field Offices - PNP Regional Directors

WHEREAS, the PNP, in a letter to the Commission dated October 19, 2004, recommending approval of the original appointments of Mr. Florante A. Vasquez III and (6) other NUPs to regular plantilla positions in the PNP based on the Resolution Nos. 2004-02, 03 and 04 of the NHQ, PNP Non-Uniformed Screening and Selection Board;

WHEREAS, the Personnel and Administrative Service of the Commission reviewed the aforesaid recommendations and determined that only six (6) recommendees have fulfilled all the requirements for the positions to which they are proposed, thus;
