RESOLUTION NO. 2005-017

***APPROVING THE REALIGNMENT OF PROMOTIONAL QUOTA FOR THE RANK
OF PINSP TO THE RANKS OF PSINP, PCINSP AND PSUPT***

WHEREAS, pursuant to Republic Act No. 6975, as amended, the National Police Commission is mandated to exercise administrative control and operational supervision over the Philippine National Police;

WHEREAS, the PNP requested clearance for the realignment of four-hundred eighty-nine (489) unfilled slots from the promotional quota of Police Inspector to the ranks of Police Senior Inspector, Police Chief Inspector and Police Superintendent for the following reasons:

- Lack of qualified applicants for PInsp. Out of the allocated quota of one-thousand three-hundred fifteen (1,315) for the said rank, seven-hundred twenty-four (724) promotional slots remain unfilled due to deficiencies in education, training, eligibility and experience requirements among the applicants for promotion.
- Excess number of qualified applicants for PSInsp, PCInsp and PSupt.

WHEREAS, in the proposed realignment of promotional quota, two-hundred (200) slots will be realigned to the rank of PSInsp, one-hundred fifty-five (155) to PCInsp and one-hundred (100) to PSupt and the remaining thirty-four (34) slots will not be realigned to any rank to accommodate the monetary impact of the said promotions;

WHEREAS, the proposed realignment, according to the Chief, PNP will not involve additional fund requirements nor distort the pyramidal structure of the PNP and will, in fact, help the PNP save by as much as Php 84,123.00;

WHEREAS, after thorough evaluation of the proposed realignment of promotional quota, the Commission finds the same to be in order, taking into consideration that the realignment is still within the range of the temporary rank distribution as provided under NAPOLCOM Resolution No. 2001-070 and that it would result to more slots for qualified applicants to the ranks of PSInsp, PCInsp and PSupt;

NOW, THEREFORE, the Commission, pursuant to its constitutional mandate to administer and control the PNP, **HAS RESOLVED TO APPROVE, AS IT HEREBY APPROVES**, the realignment of promotional quota for the rank of PInsp for the ranks of PSInsp, PCInsp and PSupt, as follows:

PCINSP	490	645	+155
PSINSP	861	1,061	+200
PINSP	1,315	826	-489

PROVIDED, that the PNP career management development program as provided for under NAPOLCOM Memorandum Circular No. 92-008 be strictly observed and its members encouraged to satisfy their deficiencies particularly in education and training requirements to maintain a pool of qualified applicants for promotion.
