RESOLUTION NO. 2005-021

RECOMMENDING TO HER EXCELLENCY, PRESIDENT GLORIA MACAPAGAL ARROYO, THE PROMOTION OF POLICE SENIOR SUPERINTENDENT NICASIO JAVIER RADOVAN, JR TO THE NEXT HIGHER RANK OF POLICE CHIEF SUPERINTENDENT PURSUANT TO SECTION 33 (A) OF REPUBLIC ACT NO. 8551

WHEREAS, under Section 38 (a) of Republic Act No. 6975, as amended by Section 33 of RA 8551, to wit:

SEC. 38. Promotions - (a) A uniformed member of the PNP shall not be eligible for promotion to a higher position or rank unless he or she has successfully passed the corresponding promotional examination given by the Commission, or the Bar, or the corresponding examinations for technical services and other professions, has satisfactorily completed the appropriate and accredited course in the PNPA or equivalent training institutions, and has satisfactorily passed the required psychiatric/psychological and drug tests. In addition, no uniformed member of the PNP shall be eligible for promotion during the pendency of his or her administrative and/or criminal case or unless he or she has been cleared by the People's Law Enforcement Board (PLEB), and the Office of the Ombudsman of any complaints proffered against him or her, if any.

WHEREAS, on November 2, 2004, the Senior Officers Placement and Promotion Board (SOPPB) convened, deliberated and passed upon the promotion of Police Senior Superintendent Nicasio Javier Radovan, Jr, presently designated as District Director, Central Police District, NCRPO, through SOPPB Resolution No. 2004-69;

WHEREAS, the Chief, PNP, in his letter dated November 24, 2004, certified that subject officer fully meets all the requirements for regular promotion to the next higher rank of Police Chief Superintendent and has been cleared from money and property accountability and from any pending case, criminal or administrative;

WHEREAS, based on the PNP Rank Profile as of October, 2004, the rank of Police Chief Superintendent has six (6) promotional vacancies as shown below;

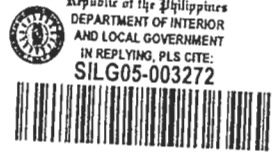
WHEREAS, the Commission finds the promotion of Police Senior Superintendent Nicasio Javier Radovan, Jr in order and in accordance with the provisions of Section 33-a of RA 8551;

NOW, THEREFORE, the Commission, pursuant to its constitutional mandate to administer and control the PNP, **HAS RESOLVED TO RECOMMEND, AS IT HEREBY RESPECTFULLY RECOMMENDS**, to Her Excellency, President Gloria Macapagal Arroyo, the promotion of Police Senior Superintendent Nicasio Javier Radovan, Jr to the next higher rank of Police Chief Superintendent pursuant to Section 33-a of RA 8551.
