RESOLUTION NO. 2005-023

APPROVING THE DESIGNATION OF SENIOR POLICE COMMISSIONED OFFICERS TO KEY POSITIONS IN THE PNP AS DEPUTY DIRECTOR AND AS EXECUTIVE OFFICER OF THE DIRECTORATE FOR LOGISTICS

WHEREAS, under NAPOLCOM Resolution No. 2002-078, no placement, assignment, reassignment or promotion involving PNP Senior Officers to key positions shall be effected without personnel action passing through the Senior Officers Placement and Promotion Board (SOPPB);

WHEREAS, the Chief, PNP, acting upon Resolution No. 2004-80 of the SOPPB, dated November 17, 2004, recommended the designation of PCSupt Eliseo Decena Dela Paz as Deputy Director and PSSupt Gerardo Capacillo Hilomen as Executive Officer of the Directorate for Logistics;

WHEREAS, the Chief, PNP, certified that PCSupt Dela Paz and PSSupt Hilomen meet all the requirements for designation to key positions in the PNP and have been cleared of money and property accountability and of any pending case, criminal or administrative;

NOW, THEREFORE, the Commission, pursuant to its constitutional mandate to administer and control the PNP, **HAS RESOLVED TO APPROVE, AS IT HEREBY APPROVES** the designation of the following senior police commissioned officers as Deputy Director and as Executive Officer of the Directorate for Logistics:
