RESOLUTION NO. 2005-024

APPROVING THE DESIGNATIONS OF PCSUPT RICARDO CALIMLIM QUINTO AND TWO (2) OTHER SENIOR POLICE COMMISSIONED OFFICERS TO KEY POSITIONS IN THE PNP AS DIRECTORS FOR TRAFFIC MANAGEMENT GROUP AND LOGISTICS SUPPORT SERVICE, RESPECTIVELY, AND DEPUTY REGIONAL DIRECTOR FOR OPERATIONS, PRO 12

WHEREAS, under NAPOLCOM Resolution No. 2002-078, no placement, assignment, reassignment or promotion involving PNP Senior Officers to key positions shall be effected without personnel action passing through the Senior Officers Placement and Promotion Board (SOPPB);

WHEREAS, the Chief, PNP, acting upon Resolution No. 2004-72 of the SOPPB, dated November 9, 2004, recommended the confirmation of PCSupt Ricardo Calimlim Quinto and two (2) other senior police commissioned officers to key positions in the Philippine National Police as Directors for Traffic Management Group and Logistics Support Service, respectively, and Deputy Regional Director for Operations, PRO 12, as follows:

PCSUPT AMETO GIL TOLENTINO



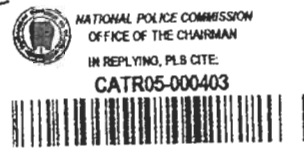
