**RESOLUTION** 2005-026

**GRANTING HEIGHT WAIVER TO MR. RIC A. QUEJADO, SEVENTEENTH  
(17TH) PLACER IN THE CRIMINOLOGY LICENSURE EXAMINATION**

**WHEREAS**, Section 15 of Republic Act No. 8551, otherwise known as the "PNP Reform and Reorganization Act of 1998," provides for age, height, weight and educational waivers for initial appointment in the PNP when the number of qualified applicants fall below the minimum annual quota;

**WHEREAS**, the implementing rules and regulations on waiver require the Commission en banc to grant waivers of the aforesaid age, height, weight and educational requirements and in order to facilitate action on waiver applications a Committee on Waiver was created for the purpose;

**WHEREAS**, the Commission issued Resolution No. 2002-048, allowing the direct filing with the Commission without need of endorsement from the Chief, PNP, of applications for age and height waivers by the top twenty board passers of the Criminology Licensure Examination and related disciplines, provided that the number of examinees is more than 2,000;

**WHEREAS**, Resolution No. 2002-048 further provides "that should the number of examinees be less than the aforementioned cut-off number, the aforesaid privilege shall be limited to the Top 10";

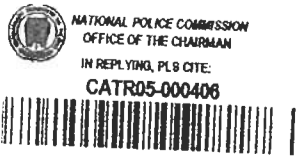
**WHEREAS**, Mr. Ric A. Quejado, seventeenth (17<sup>th</sup>) placer in the Criminology Licensure Examination given in September 2001, applied for the grant of height waiver;

**WHEREAS**, the Committee on Waiver requested a certification from the Professional Regulation Commission as to the number of examinees who took the Board on said date;

**WHEREAS**, as certified by Ms. Emma T. Francisco, Officer-in-Charge, Records Section, Professional Regulation Commission, 5,621 examinees took the Criminology Licensure Examination in September 2001, in which the applicant garnered seventeenth (17<sup>th</sup>) place;

**NOW THEREFORE**, the Commission, pursuant to its constitutional mandate to administer and control the PNP, **HAS RESOLVED TO GRANT, AS IT HEREBY GRANTS**, height waiver to Mr. Ric A. Quejado;
