RESOLUTION NO. 2005-027

**CONFIRMING THE RESULT OF THE COMPREHENSIVE REVIEW OF RANK
ADJUSTMENTS OF PSINSP. MAURO DIZON FLORES AND TWENTY SIX (26)
OTHERS**

WHEREAS, under Section 85 of Republic Act No. 6975, a Board of Officers was created under this Commission for the purpose of establishing a single lineal roster for officers and another for non-officers of the former Philippine Constabulary (PC) and the Integrated National Police (INP) and of adjusting the ranks or grades of those so affected by the merger when found to be qualified.

WHEREAS, said Board of Officers had promulgated Resolution No. 3, dated 27 March 1992, as amended, which provided, among others, the guidelines and the criteria for such rank adjustments, which guidelines and criteria had been further amended under Board of Officers' Resolution No. 13 and confirmed by Napolcom Resolution No. 98-011 dated January 9, 1998;

WHEREAS, under Memorandum Circular No. 93-004 dated 06 April 1993, the Commission directed the Chief, PNP to submit all recommendations for rank adjustment to this agency for approval;

WHEREAS, in accordance with the above guidelines, the Chief, PNP screened and recommended the rank adjustments of police officers of all regional offices and national support units;

WHEREAS, reports have reached the Commission that some unqualified PNP personnel had been recommended for rank adjustment and issued adjustment orders;

WHEREAS, because of these reports, the Commission directed the PNP to conduct a comprehensive review of all rank adjustments pursuant to Resolution No. 93-036 dated November 4, 1993 as amended by Resolution No. 2001-084 dated December 11, 2001;

WHEREAS, the PNP recommended the rank adjustments of police commissioned officers and police non-commissioned officers covered by the comprehensive review, subject to confirmation by the Commission;

WHEREAS, twenty seven (27) more are qualified for rank adjustment upon review by the Personnel and Administrative Service as listed below;
