RESOLUTION NO. 2006-006

**RECOMMENDING TO HER EXCELLENCY, PRESIDENT GLORIA MACAPAGAL ARROYO,
THE PROMOTION OF POLICE CHIEF SUPERINTENDENT NOE A WONG
TO THE NEXT HIGHER RANK OF POLICE DIRECTOR**

WHEREAS, on December 16, 2005, the Senior Officers Placement and Promotion Board (SOPPB) convened, deliberated and passed upon a resolution recommending the promotion of PCSupt Noe A Wong, presently designated as the Director for Logistics (DL), through SOPPB Resolution No. 2005-323;

WHEREAS, the Chief, PNP, in a letter to the Commission, dated December 16, 2005, certified that subject PCO fully meets all the requirements for promotion to the next higher rank of Police Director and has been cleared from money and property accountability and from any pending case, criminal or administrative;

WHEREAS, based on the list of vacancies in the PNP third-level ranks as of November 18, 2005, the rank of Police Director has three (3) promotional vacancies.

WHEREAS, the Commission finds the proposed promotion of PCSupt Wong to the next higher rank of Police Director in order;

NOW, THEREFORE, the Commission, pursuant to its constitutional mandate to administer and control the PNP, **HAS RESOLVED TO RECOMMEND, AS IT HEREBY RESPECTFULLY RECOMMENDS**, to Her Excellency, President Gloria Macapagal Arroyo, the promotion of Police Chief Superintendent Noe Albano Wong to the next higher rank of Police Director, subject to the condition he passes the oral phase of the CSEE..
