RESOLUTION NO. 2011-263

**CONFERMENT OF POLICE EXECUTIVE SERVICE ELIGIBILITY (PESE) ON  
ADOLPH CANO ALMENDRA AND TWENTY-SEVEN (27) OTHERS**

**WHEREAS**, Section 23, of Republic Act No. 6975, otherwise known as the PNP Law of 1990, as amended by R.A. No. 8551, provides that the National Police Commission shall administer the entrance and promotional examinations for policemen on the basis of standards set by the Commission;

**WHEREAS**, Section 38 (a) of R.A. No. 6975, as amended by Section 33 of R.A. No. 8551, also provides that – "A uniformed member of the PNP shall not be eligible for promotion to a higher position unless he or she has successfully passed the corresponding promotional examination given by the Commission, or the Bar, or the corresponding board examinations for technical services and other professions,..."

**WHEREAS**, the Supreme Court ruled that "it is the promotional examination administered by the National Police Commission which would entitle a police officer to the appropriate eligibility for promotion" (G.R. No. 141732, April 17, 2001);

**WHEREAS**, the Commission issued Resolution No. 2006-082, prescribing the Police Executive Service Eligibility as the eligibility requirement for Third Level ranks (Senior Superintendent and higher in the PNP);

**WHEREAS**, the National Police Commission conducted the third PESE Written Examination on December 5, 2010 in three major test centers: NCR for Luzon, Cebu City for Visayas and Davao City for Mindanao in which One Hundred Fifty Seven (157) out of Three Hundred Twenty Eight (328) qualified for the second phase of the examinations process which is the Panel Interview;

**WHEREAS**, the National Police Commission conducted the validation interview phase which is the final stage of the Police Executive Service Eligibility process to One Hundred Seventy Eight (178) interviewees on March 19 and 26, 2011 wherein One Hundred Fifty One (151) successfully passed said Panel Interview Phase

**WHEREAS**, NAPOLCOM issued Res. No. 2011-100 conferring the Police Executive Service Eligibility to the One Hundred Fifty One (151) successful examinees;

**WHEREAS**, the Commission conducted a special interview on July 9, 2011 to Thirty Two (32) candidates who passed the written phase of the Eligibility process;

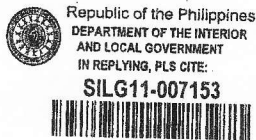
**WHEREAS**, out of the Thirty Two (32) candidates, Twenty-Eight (28) passed as deliberated upon by the Commission;

**NOW, THEREFORE**, the National Police Commission, by virtue of its constitutional mandate to administer and control the Philippine National Police, **HEREBY RESOLVES TO CONFER, AS IT HEREBY CONFERS**, the Police Executive Service Eligibility (PESE) on the Twenty-Eight (28) successful examinees whose names are enumerated hereunder:
