NOTICE TO APPLICANT

1. An applicant must be a Filipino citizen of good moral character and must hold the rank of Police Lieutenant Colonel (PLTCOL) in permanent status.
2. The following documents shall accompany this application form upon filing:
 - a. Copy of attested appointment (KSS Porma Blg. 33);
 - b. Three (3) identical ID photos (*one size 1"x 1" and two passport size*) with full name tag that includes the first name, middle initial and surname taken not more than three (3) months before the filing of the application. Only one (1) passport size ID photo and the one (1) 1" x 1" ID photo shall be submitted upon filing of the application. The applicant shall keep the second passport size ID photo and shall bring the same on the day of the examination for posting in the examinee seat plan. Pictures that are scanned, photocopied or computer-enhanced will not be accepted;
 - c. Examination fee of Seven Hundred Pesos (₱700.00) either in CASH or in POSTAL MONEY ORDER payable to the National Police Commission; and
 - d. Two (2) legal size window envelopes with Twenty-One pesos (₱21.00) worth of **Mailing Stamp** affixed on each envelope.
3. Accomplished application forms may be filed directly with any of our Regional Offices which shall forward the same to the Central Office. Please do not fail to indicate your testing center preference (Quezon City, Cebu City or Davao City).
4. Application form must be accomplished in PRINT/BOLD letters.

4. Black/Blue Ballpen;
5. One (1) passport size photograph
6. A Medical Certificate issued by a licensed government physician from the Barangay/Municipal/City/Provincial Health Office, or other government health monitoring center/office where the examinees reside, must be presented. It must be clearly stated that the examinee is COVID-19 free and must be issued within seventy-two (72) hours before the examination day (*Medical Certificate issued by private health institution shall not be accepted*).

WARNING: Committing any of the following prohibited acts shall result to **AUTOMATIC DISQUALIFICATION** from taking the examination.

1. Bringing in of bags, smart watches, electronic gadgets, review materials, firearms, explosives and other deadly weapon inside the school premises/testing centers (*Mobile phone is allowed but ONLY for the purpose of QR Code scanning*)
2. Committing direct or indirect form of cheating and/or possession of reference materials (codigo) that would undermine the integrity of the examination
